## Stratford Ridge/Brentwood Road Project

Michael Brown told everyone that the road project was awarded to Ronyak Paving. He also discussed the scope of the work.

Here is a recap of the meeting:

- The elevation of the road remains the same.
- Driveway aprons will be asphalt. Residents may choose to do the apron on their own if they already have a concrete apron and wish to keep it the same.
- A resident stated that most residents have concrete aprons and there is no need to encroach on people's property.
- Much discussion ensued on resident's driveway aprons. One resident in particular was very concerned about his.
- The trustees said that they would get more information on how the process will work with regard to the aprons.
- There will be a pre-construction meeting although residents are not typically invited.
- There were no county wide standards when this development was built which has caused many problems with the road work.
- The road levy hasn't changed since 2001.
- There were concerns about the cement stabilization process. John Washco, Road Superintendent, explained the pulverization process
- The county engineer will be on site during the construction process.
- A resident questioned the time schedule and if there would ever be a time when her driveway would not be accessible.
- Residents will be given advance notice when work is being done near their house.
- Project will most likely start in mid-July. We will send out notices when we know the schedule.
- There were questions on the ditches and work to be done. John stated that they are following the directions of the county engineer's office. When the development was first established, the ditches were not handled properly.
- Chuck Strazinsky compliments John Washco saying that he is the best thing that has ever happened to this township.

Mr. Brown made a motion to adjourn the meeting at 8:03 PM Mr. Strazinsky seconded. AYES: BROWN, STRAZINSKY AND MCKENNA


