**DECLARING IT NECESSARY
TO LEVY A TAX IN EXCESS OF THE TEN MILL LIMITATION**

Rev. Code Sec 5705.023, .19, .191, .194, .21, .26

The Board of Trustees of Chardon Township, Geauga County, Ohio met in special session on December 14, 2023, at Chardon Township Town Hall, with the following Trustees present:

Charles Strazinsky, Jr.

Timothy McKenna

Michael Brown

Trustee Strazinsky moved the adoption of the following Resolution:

WHEREAS, the Board has received the certification from the County Auditor pursuant to R.C. 5705.03(B)(2), and the amount of taxes which may be raised within the ten-mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said Chardon Township, Geauga County;

BE IT RESOLVED, by the Board of Trustees of Chardon Township, Geauga County, Ohio, has determined the amount of taxes which may be raised within the ten-mill limitation by levies on the current tax duplicate will be insufficient to provide an adequate amount for the necessary requirements of Chardon Township and it is necessary to levy a tax in excess of such limitation for the purpose of: ORC 5705.19(G)

For the general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges in municipal corporations, counties, or townships;

In Chardon Township as provided and authorized in Ohio Revised Code § ORC 5705.19(G); and

The levy is at a rate of 3 mills for each one dollar of taxable value which amounts to \$105.00 for each one thousand dollars of the County Auditor's appraised value, for 5 years and is additional; and

The ballot measure shall be submitted to the entire territory and the tax shall be levied on the entire territory and within Geauga County; and


The levy is to be placed on the ballot at the election held on March 19, 2024, and shall first be levied in tax year 2024 and begin collection in 2025.

BE IT FURTHER RESOLVED that the Fiscal Officer of the Chardon Township be, and she is hereby directed to certify a copy of this Resolution, along with Resolution #40, 2023 and the certification from the County Auditor received pursuant to R.C. 5705.03(B)(2) to the Board of Elections, Geauga County, Ohio on or before December 20, 2023 by 4:00pm local time and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.

Trustee Brown seconded the Motion and the roll being called upon its adoption resulted as follows: **AYES: STRAZINSKY, BROWN and MCKENNA**

Trustee Strazinsky made a motion to end the meeting at 8:01 pm. Trustee McKenna seconded.
